About Shoresh Nursery

Shoresh Nursery is a Jewish independent day nursery for 0–5-year-olds, inspired by the Reggio Emilia philosophy and Montessori pedagogy. We can accommodate up to 38 children across our 2 micro settings, Shoresh Pre-School and The Nest which is home to our exclusive baby and toddler provision. With a child-centred approach to education, Shoresh aims to inspire and motivate our children to be independent learners. Our EYFS curriculum which is deeply inspired by the Montessori approach and the philosophy of Reggio Emilia is integrated with teaching Jewish values, practices and customs as well as celebrating Jewish festivals and our immersive approach to introducing and teaching the Hebrew language.

Shoresh is a term-time nursery with flexible wrap-around holiday care that is offered all year round. We offer full and part-time sessions as well as a shorter day option and breakfast club.

About BNJC

BNJC is a Jewish community hub aimed at revitalising Jewish life in Brighton and Hove. Our state-of-the-art community centre provides facilities for residential, educational, cultural, religious, social and co-working.

By building a brand-new Synagogue, outstanding kosher dining options and a rich programme of events, we aim to support Jewish life in Brighton, across the spectrum and attract the Jewish community from all backgrounds to call Brighton and Hove their home.

The site includes both residential properties and commercial premises, located at 29-31 New Church Road, Hove. Alongside 45 residential units, the BNJC site comprises of Shoresh Nurseries; Novellino Brighton, a restaurant including a bakery and deli; Pro Fitness Gym, a Co-working space and events spaces. The site is shared with the Brighton and Hove Hebrew Congregation (BHHC) who operate the Synagogue and Mikvah.

You'll need to be patient, helpful and enthusiastic in your approach to work and dedicated to building strong relationships across Shoresh and the wider BNJC team.

Duties and responsibilities

- Plan and deliver age-appropriate activities and experiences in line with the EYFS curriculum.
- Work as part of a well-qualified and experienced staff team and contribute to the running and development of the nursery.
- Support the integration of daily, weekly, monthly and yearly Jewish practices, customs and festivals into the day-to-day running of the nursery alongside our on-site Rabbinic couple, R'Matt and Sheerelle Marks.
- Monitor children's food and drink consumption, feeding younger children and supervising older children during mealtimes.
- Support children with personal hygiene including changing babies and assisting with toilet training when required.
- Maintain accurate records of your key children's development and learning journeys and share with parents, carers and other key adults in the child's life.
- Develop and maintain strong communication with parents/carers to facilitate day-to-day caring and early learning needs both in person and via the Famly platform.
- Attend out of working hours activities, e.g. training, staff meetings, prospective parent events etc.
- Be flexible within the working practices of the setting, undertaking other responsible duties where needed, such as preparation of snack meals, cleansing of equipment, etc.
- Ensure the health and safety of children and staff is maintained during all activities, both inside and outside the setting.
- Adhere to the nursery policies and procedure, as well as legislative requirements relating to childcare.
- To attend staff meetings as required and to undertake such other duties consistent
 with the nature and responsibility of the post as may be reasonably assigned by the
 Executive Headteacher.

Person specification

- A minimum Level 3 or above Early Years Education and Childcare Qualification or equivalent.
- At least 2-3 years of successful experience of teaching in early years.
- Experience of working in a Jewish early years environment.
- An understanding and interest of the Montessori pedagogy and child-led practice. (You do
 not need to have direct experience of working in a Montessori setting, but we do require
 the candidate to have an interest in the Montessori approach).
- Highly effective communication, interpersonal and emotional intelligence skills which facilitate trust and positive relationships with staff, parents, children and the wider community.
- Understanding of the importance of appropriate information sharing and confidentiality in supporting children's and families' wellbeing.
- Knowledge and understanding of IT based systems and digital platforms.
- Right to work in the UK.
